EDUCATION GRANTS

The Trustees held their first hui for 2015 in February and there is good news, education grants and subscriptions to Mathsbuddy will be available this year to Hapū Trust members. Your feedback about aligning the payment of intermediate and secondary grants closer to the beginning of the school year has also been heard. To achieve alignment there will be two rounds of intermediate and secondary grants within the 2016 financial year. The first round will open 16 March 2015 and close 31 May 2015. This will be for all education grants i.e. apprenticeships and work related, tertiary, secondary and intermediate. Another round will open just for intermediate and secondary school education grants in November 2015 and close in February 2016. Tertiary grants for 2016 will open in March 2016. 
MATHSBUDDY

TRUST REVIEW - PROCEEDINGS IN THE MĀORI LAND COURT



You will recall in November 2014 the Māori Land Court (MLC) directed that a vote on the future management of the RUHT take place. The Court released the results of the vote in February and it was a positive outcome for the RUHT. The Trust would like to thank those of you who took part in the vote. Below is an overview of the Trust Review proceedings to date.

Over the last decade there have been ongoing proceedings in the MLC involving the RUHT. There were applications for review filed by the trustees of the RUHT and Norman Tane. Adrian Martin filed a related application seeking the enforcement of obligations of trust.

The MLC and the Māori Appellate Court heard these applications and directed consultation with the beneficiaries about the future management of the RUHT. The parties were required to present their vision statements for the use and administration of Hauturu East 8.

The consultation hui were held at Te Tokangānui-a-noho Marae in Te Kuiti on 13 April 2013 and 2 August 2014 after which the MLC directed that there be a postal vote on the proposals put forward by the RUHT and a joint proposal from Tane/Martin.

In the postal vote Option 1 was the RUHT vision statement where Hauturu East 8 would be administered in accordance with the Wai 51 settlement for the benefit of all the descendants of the 22 original owners of Hauturu East 8. The fundamental basis of Option 1 was to protect and preserve the Wai 51 settlement for future generations.

In the postal vote Option 2 was the variation to the RUHT proposed by Tane/Martin. Under their proposal the RUHT would be required to distribute 80 percent of the income from Hauturu East 8 to individual beneficiaries.

In short, Option 2 would have favoured short-term individual gain over a broader Hapū endowment as envisaged by the Wai 51 settlement.

The MLC was responsible for the voting process and acted as the returning officer. There were 244 votes in favour of Option 1 and 189 votes in favour of Option 2. The beneficiaries therefore voted by a clear majority in favour of Option 1 as proposed by the RUHT.

The applications will now return to the MLC for further evidence and legal submissions from the parties. It is expected that the MLC will release its final decision by late 2015. The results of the vote can be viewed on our website.

TE ROHE POTAE INQUIRY



On the 29 August 2008 Josephine Anderson, on behalf of the RUHT and the Hapū of Ruapuha and Uekaha, filed claim Wai 1805 with the Waitangi Tribunal.


This claim relates to the recording and implementation of the Wai 51 settlement between Ruapuha and Uekaha and the Crown in 1990. There were two reasons for the claim. The first was that the Crown did not properly record and implement the Wai 51 settlement and there are various matters that remain outstanding some 25 years later. The second reason was the Tane/Martin applications filed in the MLC which sought to vary the terms of trust for the RUHT which could have varied the Wai 51 settlement.

Wai 1805 was heard as part of the Te Rohe Potae inquiry of the Waitangi Tribunal. The position of the Crown is that if there were any defects with the recording and implementation of the Wai 51 settlement then It was the responsibility of the mediator and the Waitangi Tribunal.

The RUHT filed a submission in reply to the Crown on the 9 March 2015. There are good evidential and legal grounds to contest the Crown's submissions about the recording and implementation of Wai 51. At the final hearing Judge Ambler noted that it may be possible for the Waitangi Tribunal to release a separate and early report containing findings on Wai 1805 to assist the RUHT in ongoing negotiations with the Crown. The RUHT will invite the Waitangi Tribunal to do so to assist the early settlement of Wai 1805.

HIGH SEASON AT THE CAVES





Every day at the Waitomo Glowworm Caves many of our whānau and Hapū trust members take care of visitors from all over the world. It's always a busy time at the Caves during the high season and this year has been no exception with visitor numbers surpassing last season. The high visitor numbers has kept the guides, reservations team, retail team and food and beverage teams fully occupied.

Hapū trust member Huia Davis who is Head Guide at the Caves says "There are always opportunities for employment during the high season for trust members looking for holiday work. We look for people that have the right attitude and a good work ethic. Generally

speaking we start recruiting in October-November for the summer period. Job vacancies are posted on the THL website www.thlonline.com and on the RUHT's Facebook page".

Hapū Trust members who are suitably qualified are given preferential employment at the Caves. Registering on the THL website means you will be updated on all job vacancies as they become available. The Caves is a great place for school leavers and tertiary students to find work during the summer months and we hope to see more of our people working at the Caves

NGĀ INGOA O NGĀ WAAHI I WAITOMO
