Kaumātua Hauora Grants

There has been a change regarding the Kaumātua Hauora Grants. The age for Kaumātua has changed from 65 years old to 60+. Whanau who are aged 60+ can now apply anytime during the year but only one application can be made every year. However payments will be made on a quarterly basis in corresposadence with the Hapū Development Committee meetings.

Free of charge (FOC) entry to the Waitomo Glowworm Caves is for the benefit of members (and their spouses) of the Ruapuha Uekaha Hapu Trust who whakapapa to one (or more) of the following tupuna;

Please ensure that you book at least three days in advance. Groups of more than 10 must book a week in advance. Please note only RUHT members (and their spouses) are free, non hapu members will be required to pay. Large group bookings will require a list of names.

The caves are open Thursday to Monday. Please note Saturday's are not available for whanau bookings. If you wish to go through on a Saturday you will be required to pay and pre bookings are essential.

Times for whanau going through are still the same 9am-10am or 2.30pm-4.00pm (times may change subject to availability).

If you and the whanau would like to go through please ensure that you pre book by contacting the RUHT office Monday-Thursday(Closed Public Holidays), 9.00am-4.00pm.

Please note disrespectful behavier towards the guids or staff will not be tolerated and if this does occur you will be asked to leave.

Please share this information with whanau so they are aware of the booking process.



OUR PEOPLE





Although mostly known as an artist and singer, Tiki's true passion has always been mixing and production. At the age of 14, he established his first band Cultivation and at the age of 16 completed a course in Audio Engineering at a place called Mataa Waka in Ōtautahi. HIs first year at Mataa Waka involved building the actual studio, so that by the time the second year came around, it was set up for when computers came in, which changed the music industry in terms of what a producer or engineer could do.

Could you see yourself being in production and an artist at 16? Well I could definitely see a future in being a musician, roadie and live sound engineer. The production thing came later on when I joined Salmonella Dub. By the time I was 18 I was more into mixing live bands. Dave Wernham who was the original Salmonella Dub soundman, was a huge inspiration regarding my sound engineering career.

When was your first live mixing job? Heavy Metal and Punk Rock acts were my first mixes.

How did you join Salmonella Dub? They approached me in 1996 after hearing what I was doing, their manager Andrew Penman asked if I wanted to mix them up. I didn't know anything about dub as you couldn't google back then. I loved reggae and knew it was a style of reggae but didn't know exactly what it was. The term Dub originates from Jamaica and is short for duplication, so basically it refers to a new mash up of an original version. Andrew would send me cassettes and records and helped me to learn to understand what dub music was, and Mike Hodgson of Pitch Black showed me how to dub on a console.

How was it to change from mixing to singing live? It was intense and I was learning on the fly. 2000's was when I changed from mixing to being on the main stage and singing while also mixing for Shapeshifter who I have now mixed for over 20 years. They are a drum and bass band, and that style of music was not popular back then, however this has changed a lot in the last decade or so.

As an Artist is it necessary to have your own Sound Engineer? Yes, a quality performance experience is all about that live sound impact and the Sound Engineer and production help to make this happen. Its important to get them involved with the band e.g. rehearsals as this helps them to know the music, understand the sound that the band are after and be able to work on making the sound more impressive and more of a dynamic experience for the audience. If you're a new artist, I advice finding a young person who would like to learn and then grow with them along the way.

Albums His debut solo record Past, Present, Future was released 22 October 2007 and debuted at #9. The album's first official solo single, "Always on My Mind", was released 28 April 2008. The song has been certified 2x Platinum and made it to #1 in New Zealand, knocking Chris Brown off the top spot after a seven-week reign. The song spent nineteen non-consecutive weeks in the top ten, including two weeks at number one, and a total of 55 weeks in the chart so far which holds the record for being in the charts the longest.
