DEDICATION – LYNN GREEN





Our deepest sympathy and awhi go out to Lynn's whānau. The trust will forever be grateful for the mahi she has done to support the trust throughout the years.










AGM 2024 & ELECTION RESULTS

- Kaumātua can only claim for expenses within the corresponding financial year (April-March).
- Only one application can be made each financial year (March to April).
- Please note payments will be made on a quarterly basis at the end of each quarterly month (March, May, August & December).
- Please send your applications in before the start of each quarter to ensure your grants are processed by the corresponding quarter.

WAITOMO GLOWWORM CAVES FOC AND WEDDINGS



Please note FOC whānau bookings at the Glowworm Caves are not available between December and January due to peak season.

Free of charge (FOC) entry to the Waitomo Glowworm Caves is for the benefit of members (and their spouses) of the Ruapuha Uekaha Hapū Trust who whakapapa to one (or more) of the following tupuna;

- Te Riutoto Aihe
- Whatakaraka
- Te Aroa Haereiti
- Tanetinorau Opataia

Pre-Bookings are essential. You must book at least three days in advance. Groups of more than 10 must book two weeks in advance. Group bookings of more than 20 must book at least one month in advance.

Please note only RUHT members (and their spouses) are free, non-hapu members will be required to pay. Large group bookings (10+) will require a list of names.

The caves are open every day. However Saturdays are not available for Free of Charge whānau bookings. If you wish to go through on a Saturday, you will be required to pay and pre bookings are essential.

Times for whānau going through are 9am-10am or 2.30pm-4.00pm (times may change subject to availability).

Contact RUHT office to book between Monday-Friday (Closed Public Holidays), 9.00am-4.00pm.

When visiting the caves remember to be patient and respectful to the guides and enjoy your experience.

Please share this information with whānau so they are aware of the booking process.

Weddings in the Caves

Registered beneficiaries can get married at the Cave. However, the Caves is not available as a wedding venue during the high season (November to February). Enquiries can be made by contacting the RUHT Office – 0800 525 626. Terms and conditions apply for wedding bookings.

MATARIKI AT THE CAVES

In 2024 we progressed through another Matariki cycle with formal acknowledgment of the Māori New Year. Having a public holiday allows the cave to benefit from extra visitors in line with other public holidays.

The Glowworm Caves hosted another week of Matariki events with one of those being a karakia plus visit to the Caves followed by breakfast.

Whānau are encouraged to attend particularly if you have never done a tour. It's a great opportunity to reconnect with your whenua and enjoy a lovely breakfast that is free.





ACKNOWLEDGEMENT – JOSEPHINE ANDERSON



We would like to acknowledge and congratulate our kuia Josephine Anderson not only for receiving the King's Service Order for services to Māori she has received but also her mahi and support that she continues to provide to the Ruapuha Uekaha Hapū Trust.

Josephine, who is the main kuia for Waitomo Caves and the kai karanga and waiata tautoko at Tokikapu Marae near Te Kūiti, felt she did not deserve the honour.

She has devoted more than 40 years of her life to the cultural and historical preservation of land, language and tikanga in the Waitomo area, including performing an integral role in Ruapuha Uekaha hapū's Treaty settlement process over a 34 year period, as the first person to directly negotiate with the Crown.

Her involvement began with governance roles from the mid-1980s with Ruapuha Uekaha Hapū Trust and Tanetinorau Opataia Whānau Trust. She remains a current kuia advisor.

She has been a member of the Waitomo Caves Management Committee since 1990 and is a past trustee and kuia advisor for the Waitomo Caves Museum. She continues to act as a kuia advisor for Waitomo's Glowworm Caves, Caves School, Caves Water Catchment Group, and Tourism Group Holdings.

Josephine is a member of the Maniapoto Marae Pact Trust Kaumātua Group and a former member of the Māori Women's Welfare League Waitomo branch.

Anderson is convalescing at the moment, slowly regaining her health. But she is sure to have a bright smile when her whānau visit next.
